Membership Requirements

- Pool admittance is subject to dues payment and membership information submission
- To validate membership, every member must be a **Certified Member**.
 - The Certified member fee is \$100, paid as an initiation fee in the first year of membership starting in 2026 (only one fee required per family/address)
- Child care providers may be registered for pool access when no adult family member is present; a guest fee applies if an adult family member is present
- Members are immediate family or individuals who reside at the member address. No admittance without a picture of family/individual members on file. A picture must be on file for each person on your membership.
- Guest Fees: Individual guest passes cost \$5 for Mon-Fri and \$10 for Sat-Sun and Holidays, and guest passes can be purchased in advance here: <https://baldwinhillsswimclub.square.site>.
- Sign in with your first and last name upon arrival to the pool. A record of who is present is necessary to contact family, host members, or for emergency response personnel.
- The host is to sign in each guest in the Guest Sign-In binder and inform the guard of guests. Names are needed to enforce the "Members Only" policy, for fee collection, and to manage guests through host members. Members must be present with guest(s) and are responsible for their guest's compliance with pool rules. No guest may sign in on your membership if you are not at the pool.

2026 Pool Policies

- Members and guests must comply with posted pool rules and lifeguard instructions.
- Non-swimming children must be supervised by an adult at all times; floatation devices are not substitutes for supervision. Coast-Guard approved life jackets recommended.
- Children may only swim in areas appropriate to their ability. Lifeguards may require a swim test for deep-end access.
- Pool objects (rafts, balls, noodles, etc.) allowed only as permitted by lifeguards.
- Unsupervised children must be at least 13, able to swim, follow pool rules, and have signed parental permission.
- Baby pool: children 5 & under, adult supervision required; swim diapers required for non-potty trained children.
- Alcohol, smoking, and vaping are prohibited.
- Adult Swim (16 and up): 15-minute adult swim every 45 minutes; children must comply with rules.
- Diving Board: one person at a time; forward entry only; alternating hours for diving/open swim.
- Parties: scheduled ≥ 2 weeks in advance, max 15 guests, \$150 per 3-hour event; guests must follow all pool policies.

- Thunder/Lightning: everyone must exit the pool and grounds; pool reopens after 30 minutes of no activity.
- No food or drinks are permitted on the pool deck.
- No skateboards or skates are allowed on the tennis courts.

Liability Waiver & Assumption of Risk

Information (static text):

- Members acknowledge that pool activities involve inherent risks.
- Members **assume all risks** associated with pool use, including drowning, slips, falls, injuries.
- Members release, hold harmless, and indemnify Baldwin Hills Swim Club, its officers, staff, and lifeguards from any claims, injuries, or damages arising from use of the facilities.
- Compliance with pool rules and lifeguard instructions is **mandatory** for safety.
